## THIS APRIL, ARE YOU LOSING COVERAGE OR GAINING IT?

Public Health Emergency (PHE) coverage helped patients receive medical care during the height of the COVID-19 pandemic, never having to reenroll annually or worry about changing rates.

Now that the pandemic has ended, some states are rolling back PHE on April 1st. Many will lose coverage, especially those with Medicaid. Yet, this is same day Medicare benefits kick in for others.

Aeroflow Sleep wants you to be prepared if you're losing or gaining insurance. Here's what you need to do...

### I HAVE MEDICAID. WHAT SHOULD I DO?

If you have Medicaid, your coverage is issued by the state government. We strongly encourage anyone with Medicaid to speak with your state rep before March ends. This will ensure you have the healthcare coverage you need.

### I HAVE MEDICARE. AM I AFFECTED?

If you have Medicare, your coverage is issued by the U.S. government. Reenrollment isn't an issue...unless you haven't recently paid your bill. That said, you have until April 1st to reenroll or newly enroll if you need to.

### WHAT TO DO IF YOUR COVERAGE IS CHANGING


