WHO *IS* THE DOCTOR WHO DIAGNOSED MY SLEEP APNEA?

During Aeroflow Sleep's sign up-process for PAP supplies, we ask you a lot of detailed questions about your current equipment, your insurance plan, and who the doctor is who diagnosed your sleep apnea.

Patients will often enter the name of their primary care doctor or general practitioner (GP.) After all, GPs are the ones we see most often and who we are most likely to remember.

Unfortunately, if your GP did not diagnose you or—at the very least—recommend you for the sleep study, insurance will not cover any supplies prescribed by them.

HOW TO GUARANTEE INSURANCE WILL ACCEPT A PRESCRIPTION

The easiest way to guarantee insurance will accept a prescription for PAP supplies is to get the name of the doctor who performed your sleep study. They are the true sleep doctors who diagnosed you.

WHAT IF I DON'T KNOW MY SLEEP DOCTOR'S NAME?

If you don't know the name of the doctor who performed your sleep study, don't worry; Aeroflow Sleep can track that information down for you. All we really need is the name of the hospital or sleep clinic where your test was performed. However, *this extra step will delay your PAP supply order.*

HAVEN'T BEEN DIAGNOSED? NOW, YOU SHOULD CALL YOUR GP

If you haven't been diagnosed with sleep apnea yet, you can't get PAP supplies! Talk to your GP about a sleep study, and only if your test comes back positive will you then be able to start your journey with Aeroflow Sleep.
